Field crew procedures:

Each field crew consisting of 10 (ten) or less Eastern Geophysics personnel will require the following safety procedures in place prior to any field work.

- 1.) A designated safety officer in charge of all safety issues will be assigned.
- 2.) All safety issues will be brought to the safety officer's attention.
- 3.) The safety officer will be responsible to report all safety issues/concerns to management.
- 4.) A safety meeting will be held at 7:00 AM every Monday for the duration of the survey. A safety meeting form must be signed by each crew member.
- 5.) Safety concerns brought up at these meetings are to be dealt with immediately.
- 6.) Each member of the field crew will have a valid safety course.

Each crew member will be responsible for his or her own safety and the safety of the other crew members. A briefing on safety issues from each client prior to field work is encouraged. The following points are to be used as guidelines for every field crew and are presented to each crew member prior to every project.

Eastern Geophysics Limited:

- Take every reasonable precaution to ensure the health and safety of its employees
- Comply with the Workplace Safety and Insurance Act.
- Ensure the safety of the place of employment
- Make workers aware of possible safety hazards in their workplace
- Have every crew member trained (first aid course) on every job site
- Ensure that all equipment /machines/tools are maintained in good working condition according to manufacturer's specifications
- Ensure workers are trained and qualified to perform their duties
- Alert the Corporation (client) to any hazards that might affect the safety of workers
- Obey the onsite safety policies and regulations of the Corporation (client)

Eastern Geophysics Limited employees:

- Responsible to protect your health and safety and the health and safety of other people who may be affected by your work.
- Carry out the work in accordance with established safe work procedures
- Engage only in work activities for which you have been adequately trained
- Report safety concerns immediately to designated person
- Use protective equipment, devices and clothing as required
- Not engage in conduct that may endanger yourself or any other person
- Ensure that your ability to work safely is not impaired by drugs, alcohol or other causes
- Co-operate with the Workers Compensation Board
- Prompt reporting of any incident/accident to Eastern Geophysics Limited management.
- Field teams consist of at least two persons. In the case where a member of a field team is temporarily alone, their activity and location must be communicated and regularly updated with the other team members
- Means of emergency communications are carried by each crew and all crew members are trained in its use
- Sufficient personal survival and emergency equipment is carried by each crew member and is relevant to each survey, field conditions and time of year.
